

# **Privacy policy**

#### **General information**

Below you will find information on how we handle your personal data when you visit our website. Personal data are those with which you can be personally identified. The privacy policy informs users about the type, scope and purpose of the collection and use of personal data. The operator of this website treats your personal data confidentially and in accordance with the statutory data protection regulations and this privacy policy.

#### **Data collection**

The processing of data on this website is carried out by the website operator, which can be recognized in the imprint. Your data is collected when you notify us, i.e. through data which you e.g. enter in a contact form.

Additional data (so-called server log files) is automatically collected by our IT systems when you visit the website. This is data such as date and time of access, amount of data transferred, notification of successful access, browser type and version, the user's operating system, referrer URL (the previously visited page), IP address and the requesting provider.

This data is not merged with other data sources. However, the provider reserves the right to check the log data retrospectively if there are reasonable grounds to suspect illegal use.

#### Use of the data

When you contact the operator of the website (for example via the contact form or email), your details will be saved for the purpose of processing the request and in the event that follow-up questions arise. The technical data are collected to ensure that the website is provided correctly and to analyse your user behaviour for statistical purposes. This is done primarily through the use of cookies and analysis programs. You can object to this analysis or prevent it by not agreeing to its use. You can find more information on the options for objection below.

We would like to point out that data transmission over the internet (e.g. when communicating by email) can have security gaps. It is not possible to completely protect data from third-party access.

### Rights with regard to your data

You have the right to receive information about the origin, recipient and purpose of your stored personal data at any time free of charge. In addition, you have the right to correct inaccurate data, block and delete your personal data, provided that there is no legal retention requirement. # Data protection declaration for applicants

If personal data is sent to us by email or online in the course of an application, it will be stored and processed within SVS Schweißtechnik GmbH. This data is stored for the duration of the application process or until you request its deletion or correction, unless there is a legal obligation to keep it. In addition, it will only be passed on to third parties if you have expressly consented to them beforehand. The following data can be collected as part of the application process:

Personal data (first and last name, date of birth, address, graduation, etc.), communication data (telephone number, mobile phone number, fax number, email address), information (from third parties, e.g. credit agencies or from public directories), data about the assessment and evaluation in the application process, data on training (school, vocational training, civilian/military service, studies, doctorate, etc.), data on previous professional career, training and employment references, information on other qualifications (e.g. language skills, PC knowledge, voluntary work), application photos, salary requirements, application history.

### Cookies

Cookies are small files that make it possible to store specific, device-related information on the user's access device (PC, smartphone or similar). On the one hand, they serve the user-friendliness of websites and thus the users (e.g. storage of login data). On the other hand, they are used to collect statistical data on website use and to be able to analyse them in order to improve the offer. Users can influence the use of cookies. Most browsers have an option that restricts or completely prevents the storage of cookies. However, it is pointed out that the use and in particular the convenience of use can be restricted without cookies.

The basis for data processing is Art. 6 Para. 1 lit. f GDPR, which allows the processing of data to fulfill a contract or pre-contractual measures.



#### **Contact form**

The data you enter in our contact form will be saved by us for processing the request and in the event of follow-up questions. This data will not be passed on without your consent. The processing of the data entered in the contact form takes place exclusively on the basis of your consent (Art. 6 Para. 1 lit. a GDPR). You can withdraw this consent at any time. An informal notification by email to us is sufficient. The legality of the data processing operations carried out before the revocation remains unaffected by the revocation.

The data you enter in the contact form will remain with us until you request deletion, revoke your consent to storage or the purpose for data storage no longer applies (e.g. after your request has been processed). Mandatory legal provisions - in particular retention periods - remain unaffected.

### **Google Maps**

This site uses the map service Google Maps. The provider is Google LLC, 1600 Amphitheater Parkway, Mountain View, CA 94043, USA. To use the functions of Google Maps, it is necessary to save your IP address. This information is usually transferred to a Google server in the USA and stored there. Google finds out your IP address, even if there is no user account that you are logged in to. When a user account is logged in, Google can assign your surfing behaviour directly to your personal profile. This can be prevented by logging out beforehand. The provider of this page has no influence on this data transmission. The use of Google Maps is in the interest of an attractive presentation of our online offers and to make it easier to find the places we have indicated on the website. # **Google Analytics**

The website uses Google Analytics, a web analytics service provided by Google LLC (Google LLC 1600 Amphitheater Parkway Mountain View, CA 94043, USA). Google Analytics uses so-called "cookies", text files that are saved on the user's computer and that enable an analysis of their use of the website. The information generated by cookies about the use of this website by users is usually transferred to a Google server in the USA and stored there.

If IP anonymization is activated on this website, the IP address of Google users will be shortened beforehand within member states of the European Union or in other contracting states of the Agreement on the European Economic Area. The full IP address is only transferred to a Google server in the USA and abbreviated there in exceptional cases. IP anonymization is active on this website.
